About the Speakers:

Paul Amar is Associate Professor in the Global Studies Department at the University of California Santa Barbara, is a political scientist and anthropologist with affiliate appointments in Feminist Studies, Sociology, Comparative Literature, Middle East Studies, and Latin American & Iberian Studies. He currently serves as Director of the MA and PhD Programs in Global Studies, Chair of the Program in Middle East Studies, and Coordinator of the Global Security Studies Hub. Before he began his academic career, he worked as a journalist in Cairo, a police reformer and sexuality rights activist in Rio de Janeiro, and as a conflictresolution and economic development specialist at the United Nations. His books include: Cairo Cosmopolitan (2006): New Racial Missions of Policing (2010): Global South to the Rescue (2011): Dispatches from the Arab Spring (2013); The Middle East and Brazil (2014), and The Security Archipelago: Human-Security States, Sexuality Politics and the End of Neoliberalism, which was awarded the Charles Taylor Award for "Best Book of the Year" in 2014 by the American Political Science Association.

Kathryn Bond Stockton is Distinguished Professor of English and Associate Vice President for Equity and Diversity at the University of Utah. Her most recent books, Beautiful Bottom, Beautiful Shame: Where "Black" Meets "Queer" and The Queer Child, or Growing Sideways in the Twentieth Century, are published by Duke University Press and both were finalists for the Lambda Literary Award in LGBT Studies. In 2011, she taught at the School of Criticism and Theory at Cornell University, where she led a seminar on "Sexuality and Childhood in a Global Frame: Queer Theory and Beyond." In 2013, she was awarded the Rosenblatt Prize for Excellence, the highest honor granted by the University of Utah.

Sarah Chinn teaches in and is chair of the English Department at Hunter College, CUNY. She is the author of *Technology and the Logic of American Racism: A Cultural History of the Body as Evidence* (2000) and of *Inventing Modern Adolescence: The Children of Immigrants in Turnof-the-Century America* (2009). She recently completed a manuscript on representations of white masculinity on the early American stage, and is beginning a new book on amputation as a trope for loss in the years after the Civil War. She's published widely in childhood studies, queer studies, disability studies, and 19th century American literatures and cultures.

Anna Mae Duane is an Associate Professor of English at the University of Connecticut, where she teaches classes in African American literature, Disability Studies, Childhood Studies, and early American literature. She is the author of Suffering Childhood in Early America: Violence, Race and the Making of the Child Victim (2010), and the editor of The Children's Table: Childhood Studies and the Humanities (2013). She is coeditor of the Common-place.org.

Julian Gill-Peterson is Assistant Professor of English and Children's Literature at the University of Pittsburgh. He is currently at work on a book examining the transgender child across the twentieth century. His recent or forthcoming

publications can be found in GLQ: A Journal of Lesbian and Gay Studies, Transgender Studies Quarterly, Women's Studies Quarterly, and Women and Performance: a journal of feminist theory. He is also co-editor of "The Child Now," a forthcoming special issue of GLQ.

Clifford Rosky is Professor of Law at the University of Utah's S.J. Quinney College of Law, where he teaches courses on constitutional law, criminal law, and sexuality, gender and law. Before joining the faculty, he served as a Research Fellow for the Williams Institute on Sexual Orientation Law & Public Policy at the UCLA School of Law. He is a two-time recipient of the Dukeminier Award, which recognizes the best legal scholarship on sexual orientation and gender identity published in the previous year. He was one of the primary authors of SB 296, a Utah law that prohibits discrimination based on sexual orientation and gender identity in employment and housing.

Mary Zaborskis is an English PhD candidate and Fontaine Fellow at the University of Pennsylvania. She works at the intersections of queer, indigenous, and childhood studies in late nineteenth- and twentieth-century American literature. Her dissertation examines the management of childhood sexuality in boarding schools established for marginalized populations beginning in the late-nineteenth century. Mary's work has appeared in WSQ: Women's Studies Quarterly, GLQ: A Journal of Lesbian and Gay Studies (forthcoming), and Journal of Homosexuality (forthcoming). She has contributed reviews to Public Books and Women & Performance: a journal of feminist theory.
